## How does ChainConnect work?

An initial meeting will be arranged with your Travelife Account Manager to help them understand your current sustainability initiatives and goals. They will help you assess each of your properties to decide which are ready to start their certification process.

**A Head Office Document Check** will take place with your Travelife Account Manager and Certifications Specialist or Approved Auditor. They will review the records, policies, procedures and reports you have prepared relating to legislation, business permits, labour, human rights, environmental management, community and guest engagement.

**A Document Check Report** will be prepared by the Travelife Certifications Specialist or Approved Auditor to let you know if any improvements need to be made before moving to the next stage of preparing your properties for audit.

**Property Audit Preparation** involves the head office working with each property to assess themselves against the Travelife Checklist, then implementing a plan to make any required improvements before the audit takes place.

**The Audits** will be scheduled when you let us know the properties are ready. Wherever feasible, these will all be undertaken by the same Approved Auditor and we will ensure they are familiar with the outcomes of your Document Check.

**An Audit Report** will be provided for each property that outlines any improvements that need to be made. You will work through these with the Travelife Certifications, Compliance & Quality Control Team. Once all of these are made the property will be certified.
